

Annual Report

Respected Members,

I am honoured to present the Annual Report for 2023-2024. The Report serves to provide an overview of MESCO Education Society's (MES) work and to take stock of its accomplishments during the past year from 1st April, 2023 to 31st March, 2024.

I am delighted to share that MES has consistently performed well and improved its outreach during the said financial year. This has been possible due to the dedication and hard work of the staff members under the able and professional leadership of the Board of Trustees. I wish to thank all concerned for their commitment and professionalism.

With a renewed focus, we are planning to establish a Degree College at Crescent English High School building. We have to thank the Almighty for helping us all the way through the unstinted support and commitment of our donors.

Finances during the year: The Audited Balance Sheet for the year under report shows that the Trust Funds / Capitalized amount stands at Rs. 6.62 Crores, while Investments are at Rs. 1.99 Crores. The Income and Expenditure Account for the same period shows an income of Rs. 15.40 Crores (including Rs. 4.26 Crores donation for New School Construction) as against an expenditure of Rs. 12.21 Crores, leaving a surplus of Rs. 3.19 Crores for School Construction; the said surplus amount will be utilized in the next financial year on the said purpose.

We are extremely happy to share that FCRA Certificate of MESCO Education Society is renewed by the Ministry of Home Affairs, Govt. of India, for a period of five years from 1st October 2023 to 30th September 2028.

From 2<sup>nd</sup> Oct. to 30th Nov. 2023, MES participated in Give 100 Heroes Fund Raising Event and stood at 27th Rank; it was able to raise Rs. 24.15 Lakhs from 37 supporters.

We would like to thank our Auditors M/s. CNK & Associates LLP and all Banks for their co-operation and support.

Corporate Social Responsibility (CSR): Since 2021, MES is registered with the Ministry of Corporate Affairs for undertaking CSR activities, as also registered under the National CSR Exchange Portal of Ministry of Corporate Affairs (MCA). We are grateful to corporate donors for contributing Rs.24 lakhs during 2023-24 for our projects.

Prof. Farhaan Makba (Treasure) & Mr. Mohsin Shaikh (Executive Officer) attended American Federation of Muslims of Indian Origin (AFMI) Conference in Aurangabad from 29th Dec 2023 to 2nd Jan 2024. A documentary on MES activities, titled 'The

Legacy of Dedication- the Noble Journey continues' was released on 29th December 2023 at the Award Ceremony at Aurangabad, hosted by AFMI.

On 26th February 2024, Mr. Imam Patel (Administrative Officer) attended a conference in New Delhi, an initiative by Indian CSR Social Impact Awards.

On 13th December 2023, MES organized a felicitation of India's Heroes - the Rat Hole Miners who rescued 41 workers from Silkyara tunnel in Uttarkashi.

#### Following is a brief report on our Educational Institutions:

**Nursery Schools:** Our 11 Nursery Schools serve the marginalized population residing in slums and backward areas of Mumbai. These schools are located in the Central and Western suburbs of Mumbai. Our schools catered to 353 students. During the year 85% of our passing out Nursery students have been admitted to good English Medium Schools of their respective areas, ensuring quality education for them right through primary and into secondary levels of education.

We are conducting these schools in slum pockets with professionally qualified teachers using Child Centered, Play Way Method. We charge very nominal fees and hence incur annual deficit of 55 to 60% for each of these Nursery Schools.

Out of 11 Nursery Schools, 8 Nursery Schools are supported/sponsored by few Trust and Individuals.

We are grateful to all our sponsors and donors, who have made it possible for us to continue this oldest educational institutional programme (since the last 50 years).

We would appeal to our sponsors to sponsor the other remaining schools as well; the average annual deficit per school works to about Rs. 2 Lakhs.

**Crescent English High School and Jr. College:** Founded in 1993, MES' Crescent English High School & Jr. College has a rich history of academic excellence and a tradition of nurturing young minds.

Over the years, MES' Crescent English High School & Jr. College has evolved to meet the changing needs of society while maintaining its commitment to high standards of teaching and learning. In the year 2023-2024 we had 1610 students on roll.

The school's mission is to provide a well-rounded education that encourages intellectual curiosity, critical thinking and moral integrity.

Our 19th SSC batch (2024), also got 100% results as in the past eighteen years. Of the 68 students who appeared, 39 students secured distinction (out of this 10 students scored above 90%), 26 students secured first class and 3 Students secured second class. The class average percentage of this year was 77%, and the highest score was 94.60%.

Our 7th batch of HSC (Std. XII) has also secured 100 Percentage results in all the three streams. The topper of the Science stream secured 89.67% while in Commerce stream highest was 91.50% and the topper in Arts stream scored 90.67%.

Our school received "Best School Award" in Kausa, Mumbra (Thane Taluka Level) under Mukhya Mantri Maajhhishaala Sunder Shaala Abhiyaan 2024.

14 students appeared for Maharashtra Govt Drawing Intermediate Examination. All 14 students made us proud by achieving 'A' grades.

Maharashtra State Level Maths Championship was organized by "My Robots". 2000 students from 65 schools all over Maharashtra participated in the Championship. Mst. Mohd. Ali Asgar of grade V secured 1st prize in group-I, while Ms. Sukaina Wafa secured 1st rank and Mst. Asad Ali Khan secured 2nd prize in group-II. Ms. Ansari Aaleeja of Std. IX secured 1st International Rank in Social Studies Olympiad Examination. She received a Gold Medal and Cash Prize.

On 23rd Oct 2023 Ms. Ayesha Kazi (UPSC ranker – from Thane) was invited to give a guidance lecture and share her experience and journey of her accomplishment with the Secondary & Jr. College students.

Our school was selected for the Access Micro Scholarship English Program . It was a two year program conducted by US Consulate in Collaboration with Nathani Charitable Trust.

After the 2 years session all 28 students were honoured at the Graduation Ceremony with certificates in recognition of their successful completion of Access Micro Scholarship English Program. Awards were bestowed to students for outstanding academic performance in the program.

Our school students excelled in Sports, demonstrating outstanding skill, perseverance and sportsmanship. Students showed their dedication by participating in various competitions at different level such as (i) District Sports Officer's Subroto Mukherjee Football Tournament (ii)16 students participated in under 14 boys Reformation Football Cup 2023 organised by Jamat-E-Islami Hind; all the students received Silver Medal with 5000/- cash prize (iii) Our students participated in Thane District Taekwondo Championship 23-24 at Kalyan; all participants received either Gold, Silver or Bronze Medals.

Radiant English High School and Jr. College: The building of Radiant English High School was officially inaugurated on 18th June 2023 by the School benefactors. We would like to thank our well-wishers and donors for their valuable support towards the noble cause of constructing Radiant School Building.

Radiant School infrastructure provides a friendly environment for overall development of students. Spacious classrooms, especially designed interiors for pre-primary section, Computer lab, Language lab, Arts & Craft room, Indoor Sports Room, Kids Play Area, Recreation Area and Prayer Rooms, etc. are included in the facilities for the students.

In the A.Y.2023-24, the total strength of the students from Nursery to Std. IV was 1376. Admissions were given through a lottery system; the number of applications was twice the number of seats available. The entire process of lottery was kept

transparent. Sports coaching of Volley Ball, Football, Cricket and Martial Arts is provided to the students.

Shreerang Education Society Thane organized 5th Interschool Science Carnival. 64 schools participated; our student, Ms. Shaikh Lihaaz Zahidur Rehman secured 3rd place in the Quiz contest.

The First Annual Day of the School was celebrated along with parents and other well-wishers with the theme "Colours of Life".

Parents and students of Radiant school participated in Joy of Giving week (from 2nd Oct to 8th Oct 2023) and supported the activity 'Give a little Help a Lot' by donating old newspapers, clothes, toys and scrap to MESCO (parent organization).

With effect from A. Y. 2024-25, we shall start the Junior College (XIth Science and Commerce Streams).

25% of seats in both Crescent and Radiant Schools and Junior Colleges are reserved for the Economically Weak Students and provided concession of 70% in their annual fees.

**Early Childhood Care and Education (ECCEd):** We realize the critical importance of Early Childhood as the foundation of lifelong learning, behaviour & health.

Our Govt. Certified course is dedicated to providing high quality Pre-Primary Teacher Education; 30 students enrolled for the ECCEd course affiliated to Maharashtra State Skill Board of Education.

The course caters to the all-round development of trainees by giving them theoretical as well as practical knowledge through Child Development, Health & Hygiene, Planning and Integrated teaching. We had 100% placement for all graduating Teacher Trainees who were recruited in reputed Schools.

**Vocational Training Centres at Dharavi and Mumbra**: We would like to express our sincere thanks and appreciation to Fr. Agnel Technical College for their valuable guidance and assistance in facilitating the implementation of courses at our centers in Mumbra and Dharavi over the last 16 years.

At our Mumbra facility, we offer a range of comprehensive 6-month courses including (i)Electrical Assistant (ii) Air-Conditioning and Refrigeration Mechanic and (iii) Basic Fashion Designing. Affiliated to Maharashtra State Board of Vocational Education (MSBVE). Additionally, we provide Information Technology Courses, which are conducted over a span of 3 months and are affiliated with Maharashtra Knowledge Corporation Limited(MKCL).

The number of students who completed their courses during the year under report are as follows:

Mumbra Centre: Electrician – 28, Refrigeration and Air Conditioning – 49, Dress Making and Fashion Designing – 51, Information Technology -144. In our Dharavi Centre, we specialize in delivering a Tailoring Course specifically designed for young girls. During the year under report 60 students completed their course. In the last 15 years, we have trained and skilled more than 1317 Boys and 1181 girls.

Para Medical Courses: On 2nd Nov 2023, a MOU was signed between MES and Tech Mahindra Foundation for conducting the Para Medical Courses (namely General Duty Assistant, Phlebotomy Technician course and Hospital Front Office & Billing Executive course) at Radiant School premises at Kausa Mumbra.

I would once again like to extend a special thanks to my colleagues on the Board and staff. Together, we have overcome challenges and achieve great successes. I also wish to thank our well-wishers and donors who are here as well as those who are not here but have encouraged us all through our journey of 47 years. Most certainly it is the Almighty Who has Blessed us and Guided us till this day.
