



## SECRETARY'S REPORT

**R**espected President, Executive Committee and Sub-Committee members of MESCO Education Society and distinguished Patron members, Life members, Regular members and my staff, it is indeed my pleasure and honour to present to you this 39th Annual Report of MESCO Education Society (MES).

At the outset I would like to thank God for giving us the opportunity to serve our fellow human beings through our three educational institutions namely the Nursery Schools, the Vocational Training Centres (VTC) and the Crescent English High School and now also Junior College. In achieving the results we have been fortunate to have the support of myraids of well-wishers who have participated whole heartedly in terms of time, advice, suggestions and funds. I wish to place on record services of Mr. Amjad Shaikh, (Sr. Aircraft Maintenance Engineer) an Executive Committee member, who was on leave for the year under Report but has subsequently moved to Dubai and now works for Emirates Airlines.

We will miss Mr. A. R. Sharifi our Executive Committee member, who passed away, on 4th June 2015, May Allah Forgive his sins and place him in Jannah. He was a highly respected Architect, and was actively associated with the construction of our Crescent English High School. We will also miss Haji Abdul Razzak Kalsekar who was a great supporter for MESCO Education Society's Crescent English High School. We pray to the Almighty Most High, Most Forgiving, Forgive his short comings and grant him the highest place in the hereafter.

The Balance Sheet for the year under Report shows the Corpus stands at Rs. 6.62 crores while investments are at Rs. 35.75 lacs. The Income Expenditure Account for the same period shows an income of Rs. 3.56 crores as against an expenditure of Rs. 3.42 crores leaving a surplus of Rs. 15.02 lacs. The main sources of the income is school fees and other receipts which totals to Rs. 2.36 crores while donations and grants total to Rs. 1.78 crores. Annual Conclave of the Executive and Sub-Committee was held at Lonavala on 23rd August, 2015 where Role of the Board, Portfolio Committees, the CEO/AO certain important administrative and staff issues were discussed.

Online FCRA Certificate Renewal application was completed and submitted and we have been granted renewal of the same until 2021.

Daan Utsav-Joy of Giving week was celebrated from 2nd October to 8th October, 2015 at MES, Crescent English High School.

We have been trying to tap CSR Funds for our Institutions and have been able to raise Rs. 10 lacs from these efforts.

### **Nursery Schools (12 Nursery Schools):**

We wish to place on record our gratitude for all the individual sponsors of our 12 Nursery schools who fund us the annual deficits and help us provide the first step to good education in the various slums where our Nursery schools are located.

We are happy to state that almost 90% of the 292 who were enrolled at our 12 Nursery schools were admitted to good English medium High Schools of their respective areas. Angels' Paradise Nursery school, Sewri had to be discontinued as the owner of the premises decided to increase the rent substantially, we opened another School in its place at Baiganwadi, Govandi.

On 13th February, 2016, Annual Sports were held at Kapadia Nagar, Mrs. Zaitoon Officewala [Advisory Committee member, MESCO Education Society] attended and also sponsored the snacks for the participating students.

On 6th October, 2015 during Daan Utsav, Mrs. Maniar and Mrs. Shaikh Hamida alongwith teachers from pre-primary section of Crescent English High School conducted a workshop on Teaching Aids, Puppet Making & Origami for Teachers from 10 schools from Mumbra, Kausa.

Annual Day for Nursery Schools was held on Saturday, 12th December, 2015 at National College Hall, Bandra (W). We were able to raised around Rs. 4 lacs through advertisements and sale of the souvenirs.

### **Vocational Training Centres: Dharavi and Mumbra**

At the outset we wish to place on record our grateful thanks to Fr. Agnel Technical College for the guidance and support in conducting both our centres at Mumbra as well as Dharavi.

On 18th June, 2015, we received a 35AC order for our Project namely for buying equipping and furnishing Premises for a Vocational Training Centre. According to the said order, we can collect Rs. 2.97 crores, during F.Y. 2015-16, 2016-17 and 2017-18 for this Project and for which donors will receive 100% Income Tax exemption on their donations made towards this Project. We wish to thank M/s. J.B. Chemicals, Mumbai for their munificent donation towards the Corpus. In case of Dharavi centre where we have 4 months course, we trained 117 students, while in Mumbra we admitted 281 students as against 262

budgeted.

In order to maintain the self sufficiency of previous year, fees were increased by about 15% as compared to last year. Other institutions conducting comparable courses charge twice or for some courses thrice what we charge.

On 4th and 5th March 2016 Annual Sports & Cultural Activities were organized for the students of MESVTC.

On 12th March 2016, Godrej Disha programme was held at Crescent English High School's Auditorium. This programme was for the pass-out students of various Extension Centers of Fr. Agnel Technical College, Bandra supported by M/s. Godrej. This programme is a Vocational Training initiative under Good & Green intends to give a new direction to the lives of unprivileged youth by training them in skilled employment in collaboration with renowned training institutes.

#### **CRESCENT ENGLISH HIGH SCHOOL (and now JUNIOR COLLEGE):**

In order to provide good education to a few more students we decided to increase the class numbers to 50 students from 40 at the moment. This has been made effective at the pre-primary level from 2016-17 and will proceed by natural growth here onwards at each subsequent year from 2017 onwards. We are grateful for the donation from Royal Education Society of Bombay and Saifee Welfare Society which was used for buying Desktop computers, Laptop, Printer, Antivirus Software, a Projector, Steel cupboards, chalk boards, Notice Boards, chairs, softboards, and a wooden cupboard.

We have also decided to apply for permission for extra FSI so as to add two additional floors on the existing building as we had made the provision for this when laying the foundation and plinth, we hope to double the existing nos. in the years to come.

In keeping with our objective of providing quality education to the disadvantaged sections of Society, 16 children of the newly admitted students at Nursery class were provided scholarships by MESCO.

We have a 100% pass percentage at the SSC Board exams for the 10th consecutive year; of the 72 that appeared 61 students scored a First Class of which 5 scored more than 90%. The Highest score was 92.40%. The class average performance was 73.67%.

Our School was awarded the A+ grade once again by the Dept. of Secondary Education, Govt. of Maharashtra.

On 9th June 2015 Principal Mr. Durrani Azeem, Primary Headmistress Ms. Mumtaz Patel, Pre-Primary Teachers & Std. I and II teachers attended

the training session of "Macmillan" i.e. the new curriculum introduced at the Pre-school level. Ms. Harpreet Randhawa the resource person conducted the training session.

On 6th October 2015, Thane District Taekwondo Competition was held at Dadoji Khondev Stadium. 5 students from the Secondary Section participated in the same. Ms. Shifali Kadamba from Std. IXA, won Gold Medal. Ms. Atiya Javed from Std. VIIIA won Silver Medal and Ms. Shaikh Muskan Std. IXA won the Bronze Medal.

On 10th October 2015, Inter School Volley Ball match (for under 17 girls and boys) was held at Peoples Education Society, Thane. 12 girls and 12 boys under 17 participated in the same; our Girls lost the match in semi finals and Boys reached the finals finishing at 2nd position in the Final. On 10th and 11th February Annual Sports Meet was held. For 10th February Mr. Mansoor Mukadam (Mumbai and Uday Shri Winner of Body Building) was the chief guest and Mr. Anup Thalur (Mallakhamb coach) graced the occasion on 11th February 2016.

#### **New School Project:**

We received Thane Municipal Corporation's Letter of Intent, dated 20th July 2015 allotting a Plot (54000 sq.ft.) to MESCO Education Society for constructing a School.

We have received 35AC permission from the National Committee for Promotion of Social and Economic Welfare, New Delhi, for the New School Building to be constructed on the plot allotted to us by the Thane Municipal Corporation. The Order entitles donations upto Rs. 12 crores received during 2015-16, 2016-17 and 2017-18 towards construction, equipping and furnishing of the school to 100% Income Tax exemption.

On 5th March 2016, 'Ek Aur Koshish' (a Get-together of Well-wishers of MESCO and MES) was held at Islam Gymkhana, to seek their help in raising funds for the New School Project; 38 Well-wishers attended the programme.

The Survey of the Plot was completed; on 24th February 2016 we received Survey report alongwith site plan.

We once again thank all our sponsors of our Institutions and students, for their assistance year on year and but for whom we would find it impossible to raise the deficits as we try to improve our self sufficiency at a slow pace as any steep increase in the fees affects our enrolment, particularly of the marginalised for whom we work.

### NOTES FORMING PART OF ACCOUNTS AS ON 31-03-2016

#### I) Significant Accounting Policy

##### 1) Method of Accounting

- a) The financial statements are prepared in accordance with historical cost convention.
- b) Accounts are maintained on accrual basis.

##### 2) Fixed Assets and Depreciation

Fixed asset stated at cost. Depreciation is provided on Fixed Assets on WDV method as rate prescribed in the Income tax Act 1961.

- 3) Investments are stated at cost of acquisition. Adjustment for Surplus/Deficit is accounted for or on realization of investment.
- 4) Previous year figure has been, regrouped, recast, wherever necessary.

II) During the year under review a sum of Rs. 17,73,666/- was spent towards construction of school building at Kausa, Mumbra. The said sum is shown in Schedule-B as capital work in progress towards school building.

III) The trust has been granted approval to accept donations under section 35AC of the Income Tax Act 1961 vide notification no. S.O.1632 (E) dated 17-06-2015 by the G.O.I. Ministry of Finance, National Committee for Promotion of Social and Economic Welfare (Department of Revenue), New Delhi subject to conditions as specified in the said Notification. The project for which the approval was granted related to Purchasing Premises for our Vocational Training Centre and conducting/sustaining this activity involving a total cost of **Rs. 2.97** crores for three financial years commencing from 2015-16. During the year the Trust received donation of Rs. 5,50,000/- Cumulative Rs. 5,50,000/- as donations U/s 35AC of Income Tax Act 1961 against which Rs. 0/- Cumulative Rs. 0/- is utilized during the year.

IV) The trust has been granted approval to accept donations under section 35AC of the Income Tax Act 1961 vide notification no. S.O. 2854 (E) dated 16-10-2015 by the G.O.I. Ministry of Finance, National Committee for Promotion of Social and Economic Welfare (Department of Revenue), New Delhi subject to conditions as specified in the said Notification. The project for which the approval was granted relates to School Construction Project and conducting/sustaining this activity in Rural Area at a total cost of **Rs. 12.00** crores for three financial years commencing from 2015-16. During the year the Trust received donation of Rs. 67,10,000/- **Cumulative Rs. 67,10,000/-** as donations U/s 35AC of Income Tax Act 1961 against which Rs. 39,160/- Cumulative Rs. 39,160/- is utilized during the year.



## MESCO EDUCATION SOCIETY'S Vocational Training Centres' Activities

**S**kills development is an increasingly important factor in adapting societies to changing economic and environmental conditions. Despite significant progress, too many developing countries still lack effective vocational education and training strategies.

In this age of liberalization, India is still way behind in training the people in different specializations. Vocational training is to impart specialized skills and knowledge, and instilling social and political attitudes and behavioral patterns essential for successful economic activities by people engaged in dependent employment, self-employment or subsistence work.

The Government of India in recent years has laid a lot of emphasis on streamlining vocational education so that it fulfills the emerging need of the market by focusing on employability skills.

- *MES Vocational Training Centre established in the year 2008 at Kausa, Mumbra.*
- *In collaboration with Fr. Agnel Technical College Bandra.*
- *The Centre's technical training is being assessed by Godrej & Boyce.*

The Prime Minister of India has suggested that India should set a goal to create 500 million certified and skilled technicians in the country by 2022. As we have the largest population of young people in the world, we need to invest adequately in their education and employability, to become the largest pool of technically trained manpower in the world.

Vocational Training includes training for all people who are at work or are preparing for it from the level of manual workers, craftsmen, technician to technologists, etc. Training enables people to think and act in efficient, scientific and disciplined manner. Taking these factors into consideration, the MESCO Education Society's Vocational Training Centre (MESVTC) has therefore been dynamic in terms of coverage, content and delivery

- *MESVTC conducts one year Certificate courses like;*
  - *Electrician, AC & Refrigeration,*
  - *Tailoring, Professional Beautician*
  - *Computer H/W & N/W*
  - *IT & MS-CIT courses.*

MESCO Education Society's Vocational Training Centre in collaboration with Fr. Agnel Technical College, Bandra was envisaged for training the next generation in different trades and re-orienting the existing generation. The Centre aims to provide training to boys and girls from weaker sections of society so that they make utmost use of their newly acquired talents, achieve better economic status and intermingle easily with the society. As of now, the centre offers training facilities in six diverse trades Electrician, Professional Beautician, Dress-Making & Fashion Designing, Computer Hardware & Networking, Information Technology and Refrigeration & Air Conditioning. In last seven years, we have trained & skilled more than 800 students in the different trades. There are 280 Students enrolled in all courses put together for the academic year 2015-16 (academic year is from September to August).

In our Dharavi Centre, we have trained 50 Students in Beautician Course and 67 Students in Sewing (Tailoring) course in the year 2015-16. Many of them are self employed and supporting their families.

Our technical training is being assessed by Godrej & Boyce. The technical team from Godrej visits our centers regularly which provide the extra edge for our learners. Also students from Electrician, Beautician and A.C. & Refrigeration go for Industrial visit at Godrej Company which boosts the students' self confidence for better performance.

- *After completing the courses, students are getting employment in various private & government sectors.*
- *Students are earning decent income and supporting their families.*

By the Grace of Almighty, many students are employed in different Govt. & Private sectors and earning decent income supporting their family. Some of them are working in MSEDCL, Lodha's Group, Lakme, Godrej, etc. Many of them are self employed. The average salary is Rs 8000/- p.m. & the highest earning raises above 50,000/- p.m.

The feedback collected from the students of different trades highlights the successful implementation of skill development plan. The promising results after the conduct of these non-formal vocational training courses are showcasing the MESVTC's contribution towards the employment generation and socio-economic development of the nation.

## MESCO EDUCATION SOCIETY'S Angels' Paradise Nursery Schools

With an intention to promote basic education amongst the weaker section of the society, the Nursery School programme was started in 1972-73. At present MESCO Education Society (M.E.S.) manages 12 Nursery Schools in different slum areas of Mumbai and suburbans with brand name ANGELS' PARADISE NURSERY SCHOOLS.

- *A chain of 12 English medium Nursery Schools in slum areas.*
- *Dedicating our services to young minds for their all round development and to provide a safe, clean and loving environment.*
- *The main objective of this programme is to train children from slum areas to secure admission in good English medium Schools.*

We follow the modern concepts of pre- primary education that of Child Centred/Initiated Learning in the physical classroom situation. We have a Learning By Doing Curriculum, with lot of group activity, language game, singing and experimental learning. MES has been running this programme since last 44 years.

We encourage our teachers to observe other schools curriculum and techniques. The new experience is shared with the rest of the teachers once a month.

In academic year 2015-16 five internal workshops were conducted by Mrs. Tanveer Maniar (Superintendent) & Mrs. Hamida Shaikh (Asst. Superintendent) on different topics to upgrade the teachers' skills in teaching techniques.
