





SECRETARY'S REPORT

Dr.M.A.KhatkhatayGeneral Secretary



At the outset I, on behalf of MESCO Education Society (MES), take the privilege to welcome you all to this Annual General Body Meeting. Dear members, this is quite significant that we have passed through a very eventful 42nd year. The significant events which took place during the year are mentioned below.

The progress in achieving challenging objectives during the year, is due in large part to the dedication and hard work of the staff members under the able and professional leadership of the Board of Trustees.

I wish to take this opportunity to thank all concerned for their commitment and professionalism. While the challenges ahead are not insignificant, I am confident that, we will continue to meet these challenges with enthusiasm and commitment.

We are fortunate that there has been no dearth of Well-wishers, Partners and supporters since we began our journey. In the month of April/May 2018, When I and Mr. Mohsin Shaikh (Executive Officer) visited USA for Fund Raising for our New School Project and other schemes of MESCO and MES, we were humbled by the hospitality and support provided by our well-wishers, Mr. Irfan & Ms. Asma Furniturewala, Dr. Wasim Brelvi, Mr. Salauddin Kadri and Dr. Manzoor Ghori (from California), Mr. Ali Quraishi (from New Mexico) and Mr. Irfan Inamdar (from Houston). The tour was successful, we were able to raise substantial funds along with long term commitments for various schemes of MESCO and MES.

The Balance Sheet for the year under report shows that the corpus stands at Rs. 6.62 Crores while investment are at Rs. 68.94 lacs. The Income Expenditure Account for the same period shows an income of Rs. 6.50 Crores as against an expenditure of Rs.5.03 Crores, leaving a surplus of Rs. 1.47 Crores. A significant amount received for the new School project.

During the period under report, we welcomed and inducted Ms. Lubna Masud Memon, Ms. Nadiya Masud Memon, Mr. Salman Kardame and Ms. Jahanara Nakwa as Life Members of MES.

Mr. Nazir Shaikh resigned from the trusteeship of MES due to health reasons. Mrs. Najma Kazi (Ex- Principal of Saif Tyaabji High School) has been inducted into the Managing Committee of MES.

A Conclave of the Board of Trustees & HODs was held on 1st & 2nd September 2018. The main purpose in organizing the said Conclave was that MESCO (the parent organization) was completing 50 years in September 2018 and MES was completing 41 years and the Board of Trustees wanted to review all the activities of MESCO and MES, so that the road map ahead could be chalked out for the next decade. Effective governance, transparency, accountability were key areas discussed, as also effective management of schemes and projects by staff in the light of decided policies. Goals were redefined in the light of effectiveness, credibility, viability and transparency.

ABOUT NEW SCHOOL PROJECT: With an intention to establish another A+ Quality Educational Institution on the same lines as Crescent English High School, MES had applied to Thane Municipal Corporation (TMC) in August 2014, when they advertised for a reserved plot (admeasuring 54,358 Sq.ft) for a school at Kausa Mumbra. MES was fortunate to be allotted the said plot on 30 years lease (renewable further). With the support of Rogay Charities, we have paid the Bid Premium amount (for the said plot) to TMC. The School campus will be known as Nakhuda Mohammed Ali Rogay Campus.

With all the required permissions and NOCs from government agencies, the Civil Construction Work of the new school building has started. The New School building (Ground + 5 Floors with Basement) will occupy over 90,000 Sq. ft of area and will accommodate over 3,000 students

The new building will also house a Vocational Training School (encompassing 12,000 Sq. ft .). We are happy to share that, we have been able to raise funds and got commitments from donors and Wellwishers, so as to be able to raise 75% of the project cost. The remaining 25% of the amount still needs to be raised. We solicit funds for this noble cause. We are hopeful that with the said commitments & consistent cash flow, we shall be able to complete the construction work of the New School Building in 20 months and the New School will be commissioned w.e.f. Academic Year 2021-22.

CRESCENT ENGLISH HIGH SCHOOL & JR. COLLEGE: The Academic Year of 2018-19 was a great year. The Students' strength of our school & Jr. College in 2018-19 was 1446 with 41 teaching staff, 8 non teaching staff and 12 auxiliary staff. Excellence

in academics is the hallmark of any good institution and class X and XII results of the school prove without any doubt that our students have made us proud. The class X result was 100 % (as always), out of the 69 students 25 scored distinction, 29 first class, 15 second class with highest score 90.40% and class average percentage of 69.49%. The HSC (XII) results of our second batch too was good with overall percentage of Commerce Stream being 100%, Science Stream 96.4% and Arts Stream 100%.

The School has always been committed to create an environment which helps young minds to blossom and provide a platform for individual thinking and holistic development of the child's personality.

Our Pre-Primary Section received the Best Pre-School Award from Javeda Zindagi Foundation, Mumbai. Our School was also awarded 2nd position by the Thane Municipal Corporation for Cleanliness in Swaach Bharat Campaign. Apart from preparing the children to do well in academics, special efforts are being made continuously to enable them to face challenges of the world. Our students appeared for various Competitive Examinations like Science, Maths & English Olympiad, Maharashtra Talent Search Examination, Homi Baba Bal Vaidhyanik Exam, National Talent Search Examination, Maharashtra State Scholarship Examinations, Elementary and intermediate drawing examination. Aptitude Test and Counselling sessions were conducted for class X students. Our students participated in various Co-curricular Activities such as Elocution, Drama, Essay writing, Drawing, Science Exhibition, Sports etc . "What inspires me" contest was announced by Google India-"Doodle for google". Among the 53 participants Mst.Shaikh Rufael (our student of std. I) won the 1st prize. He was awarded with the national finalist for doodle for Google -2018 trophy and certificate. He was felicitated by Hindustan Times for his best painting and initiative towards creativity. Inter School Drama and Poster Competition was organized by the Thane Municipal Corporation to create awareness about Rubella and Measles. Out of the 34 schools, our school was awarded the 2nd prize at the Drama competition. Inter school science exhibition was held at Thane, in which 96 schools participated, Ms Zainab Shaikh(our Primary Teacher) won 2nd prize for her teaching aid "Science Simplified". Ms Tasneem Bharmar(our Jr. college teacher) won 1st prize for her project "Trigonometric Clock". Conserve My Planet activity was conducted in collaboration with Sharp(NGO) and Schneider India Ltd. to inculcate the value of energy conservation in minds. 21 schools participated and MES received 4 awards namely the School Champion Award, Best Campaigner Award, Green Artist Award

and as first runner up in Energy Saving Project.

Private coaches were appointed for Football, Cricket, Volleyball and Martial Arts. 4 students participated in the inter school karate championship held at Madhya Pradesh. Ms Rida Farooque (of std. I) won the 1st prize and Mst Shaikh Saud (of Std. II) won the 2nd prize. We at MES Crescent will continue our unceasing efforts to mould the young minds into well balanced personalities with confidence and strive to be one of the best schools in Thane district.

NURSERY SCHOOLS: Our Nursery Schools serve the marginalized population residing in slums and backward areas since 1973. These schools are located in the Central and Western suburbs of Mumbai. Our schools presently numbering twelve have catered to 426 students between them.

Every year more than 85% of our Nursery students have been admitted to good English Medium Schools of their respective areas, ensuring that they get quality education right through primary and into secondary levels of education.

We are running this activity in slum pockets, where we are charging very nominal fees and hence incurring annual deficit of 50 to 55% for each of these Nursery Schools. But this has not deterred us from providing the best learning to the young minds. Child Centered, Play Way Method is followed in all our Nursery Schools, providing the tiny tots with a conducive environment and experential learning. Out of twelve Nursery Schools, seven Nursery Schools are supported/sponsored by few Trust and Individuals. We are grateful to all our sponsors and donors, who have made it possible for us to continue this our oldest educational institutional programme (since the last 46 years). For the year under report, to cover the deficit of five Nursery Schools, we raised funds by collecting advertisements for a Souvenir, which was released on 5th Jan 2019 at the Annual Day of our Nursery Schools at RD National College Bandra. We received, each month for all our 12 Nursery Schools students, Paushtik Aahar Packet (having healthy Ingredients like, Ragi, Jowar, Sugar, Milk Powder Pineapple flavoured), sponsored by India Bulls Foundation under their CSR initiative for which we are most grateful.

CRESCENT EARLY CHILD CARE & EDUCATION (ECCED) TEACHERS' TRAINING INSTITUTE: We are proud to share that all 15 students from the 1st batch of Crescent ECCEd Teachers Training Institute have been successfully appointed as Pre-school teachers in reputed schools. For the second batch 14 students enrolled. The second batch commenced on July 18th,

2018 with an orientation session, which was graced by Mrs. Zaitoon Officewala (Ex- Principal of Crescent English High School). As per the syllabus requirement, on 1st Nov 2018, students visited an NGO Mumbai Mobile Crèches at Wadala.

Since the commencement of this course, we have been trying to get affiliation of some reputed University; in this direction, we applied to Tata Institute of Social Sciences School of Vocational Education (TISS-SVE) and were granted affiliation on 6th March 2019.

We are grateful to one of our Well-wishers (from South Mumbai) for financially supporting this course.

VOCATIONAL TRAINING CENTRES: We are indebted to Fr. Agnel Technical College for the guidance and support in conducting both our Vocational Centres at Mumbra as well as Dharavi. Our Dharavi Centre had an enrolment of 103 students for Tailoring course, while our Mumbra Centre conducted 6 comprehensive courses namely Electrician, AC Refrigeration, Dress Making and Fashion Designing, IT (all of 6 months), Mobile Repairing and MSCIT (3 months duration).

MESVTC aims to provide training to boys and girls from weaker section of the society so that they make utmost use of their newly acquired talents to achieve better economic status.

In the last 10 years, we have trained and skilled more than 742 boys & 755 girls. During the year under report, we have trained 138 boys & 201 girls. The successful students were awarded Certificates at the Students Certification Distribution Function, held on 29th November 2018. Mr. Ali Quraishi (Well Wisher from New Mexico) was the Chief Guest.

We are grateful to M/s. Voltas Ltd. for their financial and technical support for conducting AC Refrigeration course.

The second edition of ex-students Directory of Vocational Training Center was published in 2017, containing a list of 646 students of the 833 students who have trained with us from 2008 to 2016 and makes interesting reading of how well the students of the various courses have fared over the years.

After completing the course, students are employed in different Govt & Private sectors and are earning decent income. On 12th Feb 2019, an 'Interview and Entrepreneurship Skills' workshop was organized at the VTC Centre for all student. The workshop was aimed at preparing the student to face Job Interviews and motivate them to explore entrepreneurship as a career option. The workshop was facilitated by Ms. Amita Jadhav and Mr. Dikamber Acharya of TISS, Mumbai.

The 'Annual Project Festival Cum Sale' of Dress Making & Fashion Designing Students was organized at our Vocational Training Centre. The sale was open for the larger community around VTC. The students displayed their stitched work and designed dresses and some of them sold them to the visitors. The idea behind arranging such an event is to build confidence of the students and to train them on Customer Management Skills.

Overall, the year was full of excitement, enthusiasm, and togetherness. I take this opportunity to thank each of my colleagues, Staff Members, Patron & Life Members, CSR Partners, Well-Wishers and donors too numerous to name individually, and but for whom, we could not have achieved all this success in our endeavours.

I look forward to the same support and passion to continue in coming days in achieving our mission.
